Allen Lane Foundation

Purpose: To support innovative projects that aim to make a lasting difference to people's lives, and reduce isolation and discrimination. The fund specifically supports: asylum-seekers and refugees; gay, lesbian, bi-sexual or transgender people; gypsies and travellers, migrant workers, offenders and exoffenders, older people, people experiencing mental health problems, people experiencing violence or abuse.

Who can apply: Smaller, not-for-profit voluntary organisations for project and core costs.

Level of funding: Up to £15,000.

Deadline: Apply anytime.

Awards for All

Purpose: This National Lottery funded programme aims to bring real improvements to communities and to the lives of people most in need. It funds projects that involve people in their communities, bringing them together to enjoy a wide range of charitable, community, educational and environmental and health-related activities.

Who can apply: Not-for-profit groups, community groups, parish and town councils, schools and health bodies.

Level of funding: £300 - £10,000.

Deadline: Apply anytime.

Bailey Thomas Charitable Fund

Purpose: To provide both research and project funding in the area of learning disability and to aid the care and relief of those affected by learning disability. The Trust consider under learning disability the conditions generally referred to as severe learning difficulties, together with autism. In this area, they consider projects concerning children or adults. The type of activities currently funded include: capital works for residential, nursing and respite care; employment schemes including woodwork, crafts, printing and horticulture; day and social activities centres including building costs and running costs; support for families, including respite schemes; Independent Living Schemes; support in the community schemes. Applications for research projects will only be considered from established research workers and will be subject to normal professional peer review procedures.

Who can apply: Registered charities or organisations associated with a registered charity. Industrial & Provident Societies can also apply.

Level of funding: Funding is normally considered for capital and revenue costs and for both specific projects and for general running/core costs. Previous projects supported have ranged from £250 to £150,000.

Deadline: For grants over £10,000 1 March and 1 August. Applications for projects up to £10,000 can apply anytime.

Brelms Trust

Purpose: To support charities working at the heart of communities to tackle disadvantage and to provide sustainable benefit to the community. Applications can include staff salaries, volunteer expenses and running costs.

Who can apply: Charities based in Yorkshire and directly benefitting only Yorkshire communities.

Level of funding: From £1,000 to £5,000 per year, either as a one-off grant or up to a maximum of 3 consecutive years; therefore a maximum grant of £15,000 per application.

Deadline: The Trustees meet quarterly, usually in March, June, September and December, to make grant awards.

Clothworkers' Foundation

Purpose: To improve the lives of people and communities, particularly those facing disadvantage in one or more of the following areas most of the time: alcohol and substance misuse; disadvantaged young people; disabled people; disadvantaged minority communities, domestic and sexual violence, elderly people, homelessness, prisoners and ex-offenders and visual impairment.

Who can apply: Main grants: UK registered charities with an annual operating income of under £15m; Small grants: UK registered charities with an annual turnover under £250,000.

Level of funding: The Foundation operates two programmes—Main grants average £25,000; Small grants up to £10,000 (average grant £7,000).

Deadline: Apply anytime.

Who can apply: Community groups, resident associations, charities and voluntary organisations.

Level of funding: The Foundation rarely makes grants smaller than £5,000 and only a small number in excess of £500,000.

Deadline: Applications can be submitted at any time. Two stage application process.

Purpose: To help organisations based in local communities deliver activities that they wouldn't otherwise be able to. All projects must support a community of interest, that is, people who are disabled or suffering chronic illness; living in poverty; voluntary carers; homeless; isolated older people; and others demonstrating significant need.

Who can apply: Small locally based organisations, that make a difference within their own communities and have a turnover of less than £300,000 and are located near a Greggs shop.

Level of funding: Up to £2,000.

Help the Homeless

Purpose: To support charities for capital costs relating to projects that assist individuals in their return to mainstream society, rather than simply offer shelter or other forms of sustenance.

Who can apply: small and medium-sized registered charities

Level of funding: Up to £5,000

Deadline: Quarterly 15 March; 15 June; 15 September; 15 December every year

Purpose: To improve the quality of life for people and communities in the UK, both now and in the future. They like to consider work which others may find hard to fund, perhaps because it breaks new ground, appears too risky, requires core funding, or needs a more unusual form of financial help such as a loan. The Foundation has always believed in the need to support and maintain a free, stable and socially cohesive society, where enterprise is encouraged and people are able to realise their potential, take advantage of opportunities and play their part in democratic life. They look for situations where small amounts of funds will make significant impact. However, they are particularly interested in the following areas: community building, strengthening nonprofits, environment, supporting families

Who can apply: Not for profit organisations.

Level of funding: The grants range from £500 – £10,000. Extraordinary projects may receive grants up to £50,000.

Level of funding: £1,500 to £5,000. In exceptional cases, a higher grant may be awarded.

Deadline: Applications must be received by the end of February or the end of August each year to be considered at the Spring or Autumn meetings. Next deadline 31st August

Leeds Building Society Charitable Foundation

Purpose: To support communities around its nationwide network of branches by making donations to charities working in those areas. Generally, the Foundation will consider applications for community based projects which aim to provide relief of suffering, hardship or poverty, or their direct consequences.

Who can apply: Registered charities

Level of funding: Grants in the range of £250 to £1,000.

Deadline: Applications can be submitted at any time. The Trustees meet quarterly in March, June, September and November.

Lloyds Bank Foundation

Purpose: To provide funding for projects to help people break their cycle of disadvantage. There are two funding programmes: 'Invest' a flexible, long term core funding programme for charities helping disadvantaged people; 'Enable' a smaller and shorter grants programme for charities that have identified clear development needs. This funding aims to help the organisations deliver their mission more effectively. Organisations are expected to be working with people experiencing multiple disadvantage at one of the critical points in their life.

Who can apply: Registered charities and charitable incorporated organisations with an income of between £25,000 and £1 million.

Funding: Invest: £10,000 to £25,000 per year for 2-3 years with the opportunity for further funding for up to 6 years in total. Enable: up to £15,000 over 2 years.

Deadline: Invest – funding is open for short periods annually and are announced on the funder's website; Enable apply any time.

Purpose: To support user involvement projects and associated activities

Who can apply: Both new and established cancer self help and support groups in the UK

Level of funding: Discretionary.

Deadline: Next deadline 22 July 2016

Purpose: provide support in a number of areas: · Financial hardship to relieve household or individual poverty by preventing or alleviating financial hardship and its effects. · Health and disability to improve the lives of those affected by poor physical and/or mental health and wellbeing including the impact of caring, life-limiting and long-term illness, and learning disabilities. · Education and employability to provide educational and employment opportunities, training and other activities that enable disadvantaged children and young people to develop the skills they need to progress in life. · Social exclusion and disadvantage to relieve isolation or loneliness by removing the barriers to an active and fulfilling life.

Who can apply: Registered charities

Level of funding: Large Grant: over £5,000 for a specific purpose only. This might be to fund salary costs, specific project costs and refurbishment costs. Charities with a turnover of over £500,000 can apply for a Small or Large grant. \cdot Small Grant: between £500 – £5,000 for charities with a turnover below £500,000. Small grants can be used for core expenditure such as general running or overhead costs.

Deadline: Applications are considered in January, April, July and October.

Morrisons Foundation

Paul Hamlyn Foundation Ideas and Pioneers Fund

Purpose: To support people with unusual or radical ideas to improve the life chances and opportunities of people to help them overcome disadvantage and lack of opportunity, so that they can realise their potential and enjoy fulfilling and creative lives.

Who can apply: Partnerships, small teams working independently and small constituted organisations employing no more than five people. Individuals can also be eligible. There is an eligibility quiz on the website.

Level of funding: Up to £10,000; up to £15,000 in a few exceptional circumstances.

Deadline: Varies; subscribe to funder's newsletter to keep up to date.

Purpose: To fund capital projects that assist people with disabilities, older people over 60 and disadvantaged youth.

What can apply: Registered charities

Level of funding: The charity has two grants schemes: Large grants: one-off payments for capital expenditure of £2,000-£5,000. Small grants: up to £500 towards furnishing and equipment.

Deadline: Applications are assessed at quarterly meetings.

Purpose: To support organisations that contribute to the common good and social change. Who can apply: Registered charities and not for profit organisations

Level of funding: Between £10,000 and £25,000.

Deadline: Apply anytime.

Rayne Foundation

Purpose: considers applications in the fields of arts, health and wellbeing, education in its widest sense, and those that cover social issues. The main focus is to connect communities, building bridges between marginalised groups and mainstream society, and to enable individuals to reach their full potential.

Who can apply: Organisations working in the arts, education, health & medicine or social welfare.

Level of funding: Typically £8,000 to £25,000 per annum for up to three years

Deadline: Apply anytime.

Reaching Communities

Purpose: This is a national lottery funded open programme for projects that help people and communities most in need. All projects must address one or more of the following outcomes: people have better chances in life, with better access to training and development to improve their life skills; stronger communities, with more active citizens, working together to tackle their problems; improved rural and urban environments, which communities are better able to access and enjoy; healthier and more active people and communities. Funding is available for salaries, running costs, a contribution towards core costs and equipment.

Who can apply: Registered charity, voluntary or community group, statutory body (including schools), community interest company, not-for-profit company limited by guarantee, community benefit society, a town or parish council.

Level of funding: Grants are available from £10,000, upwards and funding can last for up to 5 years. If you are looking for more than £500,000 you must contact the Big Lottery Fund before applying. They can also fund up to £100,000 for land, buildings or refurbishment capital costs.

Deadline: Apply anytime

Rhododendron Trust

Purpose: To support social welfare and humanitarian aid projects both in the developing world and the UK. The Trust wishes to support those disadvantaged by disability or mental illness (such as those suffering from epilepsy or autism). The Trust also supports charities which work with prisoners and exoffenders, or those addicted to drugs, and the homeless. Projects which support carers and which help the elderly or disadvantaged children are also considered.

Who can apply: Registered charities.

Level of funding: Grants of £500 or £1,000 are available. In general priority is given to smaller charities over larger ones.

Deadline: Applications can be made at any time and will be considered once a year usually in February or March.

Royal British Legion External Grant

Purpose: To support projects with the following outcome themes: employment and training; family support; homelessness and outreach; supporting the elderly. Projects must not duplicate Legion services.

Who can apply: Charitable organisations operating for at least 2 years.

Level of funding: Up to £50,000; projects must not duplicate Legion services.

Deadline: Apply anytime. Two stage application process.

Purpose: To support projects with a range of outcome themes including: medical care and treatment, including respite care and hospices; care for physically and mentally disabled adults and children; education and training for adults with physical and learning disabilities; care and support of the elderly; care and support for children; homelessness. The Trustees aim to achieve a reasonable spread between Jewish charities and non-Jewish charities.

Who can apply: Registered charities or those that are officially exempt

Level of funding: No maximum or minimum grant.
